During 2015 Sage Electronic approached us to publish TIJ. They would provide an electronic submission system and a small payment to TIJ. Authors would be charged to publish. No action since end of June, as a change of personnel has occurred. Transfer of TIJ to a library electronic system is on hold because of the Sage initiative. A library would require free access to their clients and the right to deposit papers published by TIJ in their system.

Indexers

Scopus SCImago worldwide rankings of public administration journals identified citations using Google 1996-2013. As of 2010 it started listing The Innovation Journal. The details as of the end of 2013 (it takes a minimum of two years to produce a report) are provided in Appendix E. Using an equivalent measure to that offered by Thompson Reuters, for 2010-2013 TIJ's mean citations per article during the first two years after publication is 0.45. Of the 113 public administration journals listed, as a sampling, Journal of Public Administration measured an average of 0.33 cites per paper, Journal of Public Affairs 0.6, Review of Administrative Sciences 0.87. The report on the top 113 journals is available on request to me. Using the same system of measurement as Thompson Reuters, Scopus SCImago ranked The Innovation Journal citations within two years 68th among 113 top public administration journals worldwide as of the end of 2013.

TIJ applied for indexing a second time with Thompson Reuters, which does not list many electronic journals. We have not heard any results (Sanni Yaya is handling this—see Appendix A). While Thompson Reuters relies considerably on the two-year citation record, public administration articles tend to take longer to become known. The Editor-in-Chief of Public Administration Review (PAR), the lead ASPA journal, strongly recommends against indexing with Thompson Reuters for public administration journals. Sanni will no longer pursue indexing with Thompson Reuters.

Readership - Calendar Years 2008 to 2014

TIJ had a large number of readers again during 2013. Readership may be aided by the table of contents sent out by the Editor-in-Chief for each of the three issues published. Rutgers will be doing this in future. Visits to the website are compared below for 2008 to 2013. Readership was down slightly during 2013 and had been up in 2012. In other words, readership is stable and high.

The Innovation Journal (TIJ) had a slight drop in unique readers in 2014 and increases in visits, page view and hits. TIJ defines a *reader* as someone who stays on the website for longer than 30 seconds. This definition eliminates search engines (which only remain for a few seconds), those who did a search on a related word or words, but were not looking for TIJ, and those who consult a table of contents but do not read any part of a paper. According to this definition, TIJ had 52,206 readers in 2011, 62,023 during 2012, 68,417 in 2013 and 80,432 in 2014. The one-year increase in 2014 was 17.5 per cent.

Citations

Scopus SCImago

Scopus ranks public administration journals by citations. Its SJR indicator measures the scientific influence of the average article in a journal, expressing how central to the global scientific discussion an average article of the journal is. The measure Cites per Doc. (2 years) measures the scientific impact of an average article published in the journal within two years of publication; it is computed using the same formula as Journal Impact Factor™ (Thomson Reuters). It also measures the impact within three years. Among the public administration journals listed, TIJ ranked 68th worldwide in 2013. TIJ'S ranking is outlined in Appendix G.

In 2012 there were 566 North American and 691 European public administration journals listed by Scopus. The top ten were Administrative Science Quarterly, Journal of Public Administration Research, Educational Administration Quarterly, Journal of European Public Policy, Public Administration, Review of Public Personnel Administration, International Public Management Journal, Journal of Policy Analysis and Management, Journal of Social Policy, and Policy Studies Journal.

SCImago

As of 2013, SCImago reported that TIJ was the second most cited Canadian public administration journal. They only list the three top Canadian public administration journals. The one above us is an administration journal that covers all sectors (private, non-profit and public sector), not just the public sector like The Innovation Journal. SCImago ranked us internationally in Q3, although we had higher rankings than many of the journals that appeared above us. This is not explained. As far as I can determine, it is because we have a considerable number of self-citations. This is the problem when a journal is a key player in establishing a new field. Some journals are publishing its papers when they are ready to be published as a way to increase citations. It is more costly in terms of Webmaster time to do this. We tend to get most of our citations after SCImago's two and three year windows, as our Most Cited Papers list indicates. Authors are, however, paying attention to this and one considered not submitting to us because we were not in Q1 and Q2 and she was required to publish in journals at that level. She did submit in the end, however, because she found us in Q2 in Jufo. This issue has been identified to me in particular by Europeans.

On another positive note, we are receiving more recognition from Canadians. For example, Keith Brownsey, Mount Royal College, well known Canadian academic, wrote to me December 10, 2015, saying: "I am writing to say how much I appreciate *The Innovation Journal*. Many thanks for all

your efforts on what has become a very good publication.” The papers by our Canadian Editorial Board members have helped with this: thank you very much.

Conclusion

TIJ is a success at the level of readership and author interest in publishing in TIJ. TIJ is being widely cited, ranking 39th amongst 1157 public administration journals worldwide for ratio of citations to papers within the first two years of publication. We have not yet found an adequate funding model for TIJ, however. We have found some funding for bits and pieces but no overall funding model has been created, and so we are moving to charging authors.

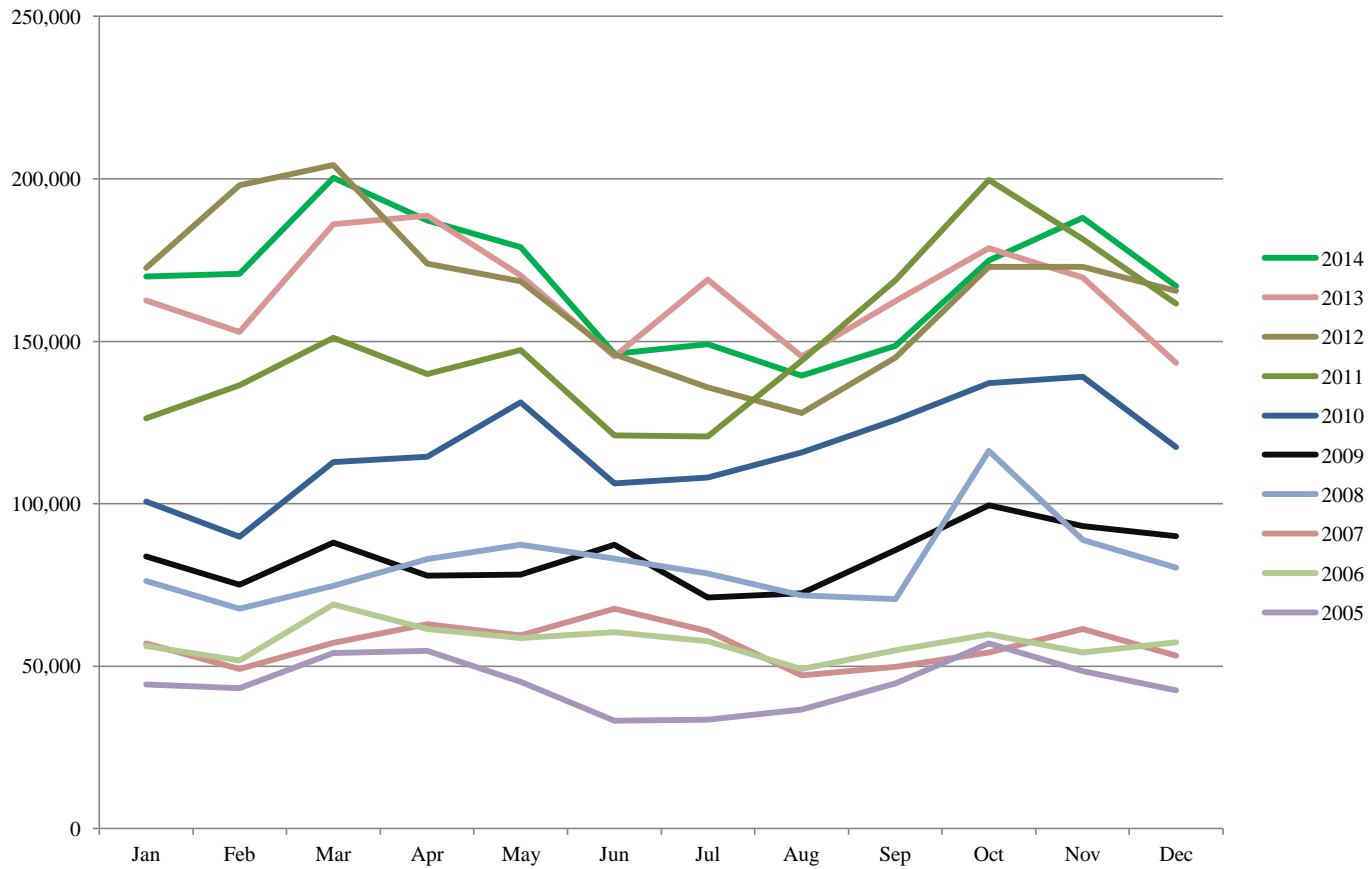
